The Bayfield County Planning and Zoning Committee of the County Board of Supervisors will hold a public hearing on Thursday, November 16, 2006 at 1:00 P.M. in the Board Room of the Bayfield County Courthouse in Washburn Wisconsin relative to the following:

Donald & June Frey are petitioning for a zoning district map amendment on their 6-acre parcel (ID #014-1033-01-000) located in the S ½ of the S ½ of the SE ¼ of the NE ¼ West of Lenawee Rd, Section 8, Township 50 North, Range 7 West, Town of Clover, Bayfield County, WI from Agricultural - 1 (Ag-1) to Residential-Recreational Business (R-RB).

Jon McKinney is petitioning for a zoning district map amendment on his 3.38-acre parcel (ID #012-1051-06-000) described as part of the NW ¼ of the NW ¼, W of the Road, Section 19, Township 43 N, Range 7 W, Town of Cable, Bayfield County, WI from Residential-1 (R-1) to Commercial (C).

Nels Ritola, agent is requesting a conditional use permit to operate a sand/gravel pit (also to include screening) on his 30-acre parcel (part of ID#'s 026-1046-02-990 and 026-1046-03) described as the S ½ of the NW ¼ of the SW ¼, and the SW ¼ of the NE ¼ of the SW ¼, Section 22, Township 46 North, Range 5 West, Town of Kelly, Bayfield County, WI. Included in this request will be the requirement(s) of the reclamation plan, which will be addressed separately.

Be advised any conditions placed on the reclamation plan shall pertain to the reclamation plan only, and any conditions placed on the non-metallic site shall pertain to the conditional use application. (Reclamation plan available for review, please call the Planning and Zoning Dept.)

Impact Seven, Inc., owner and William Bay, agent are requesting a conditional use permit to operate a machine shop on a 72-acre parcel (ID#'s 006-1002-01, 006-104-03, 006-1003-10, & 006-1005-04) described as the SE ¼ of the NE ¼, the SW ¼ of the NE ¼, the NW ¼ of the SE ¼, and the NE ¼ of the SE ¼, Section 1, Township 50 N, Range 4 W, and part of Gov't Lot 3, Section 6, Township 50 N, Range 3 W, Town of Bayfield, Bayfield County, WI.
