

TRACT 32-20 – SUPPLEMENTAL REQUIREMENTS

The following terms and conditions supplement those provided in the Bayfield County Timber Sale Contract.

A. PRESCRIPTION:

- Harvest unit 1 has a white pine shelterwood harvest prescription with an estimated average residual basal area of 60ft²
- 2. Harvest unit 2 has a northern hardwood patch cut prescription with an estimated average residual basal area of 13ft² inside the patches.
- 3. Harvest unit 3 has an oak seed tree harvest prescription with an estimated average residual basal area of 10 ft².

B. HARVEST REQUIREMENTS:

- 1. In units 1 leave all purple marked hardwoods and unmarked conifers. Harvested all hardwood stems 2 inches and greater and conifers marked in purple (balsam fir to be severed and left laying).
- 2. In unit 2 harvest all stems 2 inches and greater except conifers.
- 3. In unit 3 harvest all stems 2 inches and greater except purple marked trees and conifers.

C. HARVEST AND OPERATIONAL REQUIREMENTS AND SEASONAL RESTRICTIONS:

- 1. Oak wilt was officially confirmed within a six-mile radius of this timber sale. As a result, the following restrictions will be applied: no harvesting operations will be allowed between April 15th (or as otherwise determined by the county) and July 15th.
- 2. Unit 1 is good summer chance for operability (as determined by the county).
- 3. Unit 2 & 3 are frozen or dry ground only for operability (as determined by the county).
- 4. Utilization specification is to a 4" top. However, if the County determines that pulpwood markets continue to be very poor at the time of harvest the County will sign a contract amendment with the purchaser changing the utilization specification to a 5" top for selected species. When determining condition of the market, the County will pay particular attention to the amount of wood being purchased by the mills in Wisconsin Rapids and any other significant shifts in wood demand.
- 5. Sale boundaries include red paint line, blue paint line and spider lake road. (see aerial map).
- 6. The blue line indicates private property. No equipment or felled trees may cross the line.
- 7. If harvest will utilize the whole tree, 1 in 10 tops must be left scattered throughout the sale.
- 8. Do not damage any survey monumentation.

D. ACCESS AND ROADS:

- 1. Decking of wood along town roads will not be allowed without permission from Bayfield County.
- 2. An ATV trail runs through parts of the sale. The purchaser must ensure that harvesting and hauling operations will not create a safety hazard to ATVs (post signage). If the primary haul route utilizes a portion of the ATV trail avoid damage to signs and trail markers.
- 3. Excessive damage (beyond normal wear and tear) to the ATV trail, as determined by the county, will not be tolerated. If Bayfield County determines excessive damage has occurred, the contractor may be held responsible for a portion or all of the repair. The County and Contractor must communicate on a regular basis to ensure issues are addressed in a timely manner and the snowmobile trail remains in a safe and acceptable condition.

E. OTHER:

 To comply with Best Management Practices for Invasive Species: Prior to moving equipment onto or off the sale area, scrape or brush soil and debris from exterior surfaces to the extent practical.
